Dear Mr Cameron

I refer to the Construction Environmental Management Plan (CEMP) for the Abbotts and Aldington Road Upgrade (AARU) Phase 1 works, submitted in accordance with Condition D25 of the consent for the Westlink Industrial Estate (SSD-9138102). I also acknowledge your response to the Department's review comments and request for additional information.

The Department has carefully reviewed the document and is satisfied that it meets the requirements of the relevant conditions in the SSD-9138102 consent. It is noted that this CEMP relates to the AARU Phase 1 works, and separate CEMPs are to be submitted for the AARU Phase 2 and Mamre and Abbotts Intersection Upgrade (MAIU) works.
